Lithium Consolidated Mineral Exploration Limited (ASX: LI3) ("Lithium Consolidated" or the "Company") is pleased to report on activities during the June quarter, including the advancement of our exploration assets.

1. African Hard Rock Lithium

The Company has targeted globally significant tantalite districts in Zimbabwe and Mozambique, based on the extensive and substantial endowment of Lithium-Caesium-Tantalum ("LCT") pegmatites in these countries, where the early mining of LCT pegmatites was generally for tantalite and other pegmatitic minerals such as beryl and niobium, and not for lithium from the spodumene zones, which were generally overlooked.

The Zimbabwe and Mozambique pegmatites have been thoroughly mapped but remain largely unexploited and under-explored due to prolonged periods of underinvestment since the 1950s and 1960s.

The lithium exploration potential of the Zimbabwe and Mozambique pegmatites is analogous to that of the Pilbara Craton pegmatites, approximately 10 years or so ago, based on the Company's extensive research and investigations.

The historical tantalite districts and known LCT pegmatites of Mozambique and Zimbabwe and abandoned artisanal mines now represent a globally significant opportunity to develop new hard rock lithium resources.

With the assistance of our technical team and our local partners in Africa, we have progressed identifying and securing new, globally significant hard rock lithium exploration assets in Zimbabwe and Mozambique.

1.1. Zimbabwe

The Company has applied for new Prospecting Licenses in Zimbabwe with hard rock lithium potential, where some of these licenses have now been granted.

The Zimbabwe Prospecting Licenses (under application and granted) are all located in a historical tantalite mining district.

1.2. Mozambique

The Company has applied for new licenses in northern Mozambique with hard rock lithium potential.

2. Tonopah Lithium Project, Nevada, USA

Tonpah Lithium Project ("TLP") is in the Clayton Valley, in West Central Nevada, in the United States of America.

TLP consist of 439 placer claims over an area of 8,674 acres.




Figure 1. Tonopah Lithium Project and Reedy Lagoon's South Big Smoky project

TLP is immediately adjacent to Reedy Lagoon Corporation Limited's ("Reedy Lagoon") Big Smoky South project (see Figure 1).

Reedy Lagoon recently drilled a single hole to a depth of 401 metres at its Big Smoky South project and reported a disappointing result where fluid rates were too low for effective sampling.

We nevertheless believe that TLP remains a premier lithium brine exploration asset in North America. However, we are reviewing our strategic options with respect to TLP, in light of our decision to focus our company on hard rock lithium exploration.

There was no significant activity at TLP in the June 2018 Quarter.

3. Yilgarn Lithium Project, Western Australia, Australia

Yilgarn Lithium Project ("YLP") is a hard-rock lithium exploration asset located in the Yilgarn Province of Western Australia.

YLP consists of 16 Exploration Licenses, including 10 granted Exploration Licenses and 6 pending Exploration License Applications, covering 747 km2.

Our ASX Announcements dated 16 January 2018 and 6 April 2018 have additional information on the Yilgarn Lithium Phase 1 drilling program and results.

4. Botswana Lithium Project

The Company owns an 80% ownership interest in South Resource Ventures Pty Ltd, which has a direct interest in the Botswana Lithium Project, which consists of 6 Prospecting Licenses and 2 Prospecting License Applications in the Sua and Ntwetwe Pans in the Makgadikgadi Depression in north eastern Botswana.

Our ASX Announcement dated 27 February 2018 has additional information on the Botswana drilling program and results.

There was no significant activity at the Botswana Lithium Project in the June 2018 Quarter.

We are reviewing our options with respect to the Botswana Lithium Project.

5. Eucla Basin, South Australia, Australia

The Company's South Australian lithium brine project consists of 5 Exploration License Applications which cover a total of 5,680 km2 of the Eucla Basin.

There was no significant activity at the Eucla Basin Project in the June 2018 Quarter.

6. Corporate

The Company continues to assess new lithium exploration opportunities.

Details of the Company's financial activities during the quarter are set out in the Appendix 5B cash flow report.

7. Capital structure

At the end of the quarter, there were 90,499,122 fully paid ordinary Shares, 6.2 million unlisted Options and 7.2 million unlisted Performance Rights on issue.
